551.073 Deliberation regarding prospective gifts.

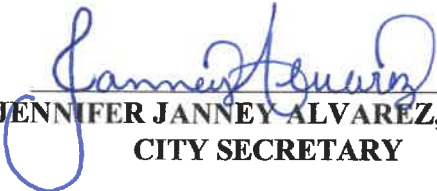
